## ŁÓDŹ RESIDENT CARD

The Łódź Resident Card will allow you to benefit from over 100 discounts and bonuses. The discounts will often equal as much as 20 percent. The project has already been joined by municipal ice rinks and swimming pools, FALA Aquapark, EC1, local restaurants and private enterprises such as cinemas, shops or service companies and taxi corporations.

The Card will be granted, after filling in a special form, to those who settle their PIT in Łódź (including retirees and pensioners), students of local higher education institutions, people registered as unemployed at the Poviát Labour Office in Łódź and high school students over the age of 18.

## TAX LOTTERY

Yet another edition of the tax lottery for Łódź residents is underway until 30 April. This time, each resident of Łódź who pays his or her taxes in our City has a chance to win. **The prize pool is over 160,000 zlotys.** New taxpayers will have an opportunity to win a special prize of 20,000 zlotys.

**The main prize is 100,000 zlotys.** In addition, there is a special prize - for new taxpayers only, amounting to 20,000 zlotys. Prize draws will be held every week (one prize of 1,000 zlotys) and every month (one prize of 10,000 zlotys). The lottery's grand finale is scheduled for the first week of May.
